SPECIAL MEETING & PUBLIC HEARING – DECEMBER 9, 2020 VIRTUAL MEETING, 9:00 AM

A special Meeting and Public Hearing of the Fenwick Historic District Commission was held using the Zoom meeting format on Wednesday, December 9, 2020. Notice of the meeting was posted in a timely manner on the Fenwick kiosk and on the website.

1. Call to order

Chairman Myers called the meeting to order at 9:00 a.m. and seated A. Gengras as a voting member. A quorum was established (Myers, Bulkeley, Neely, Keeney, Gengras).

- **2. Public Hearing: 10 Sequin Avenue, map 9, lot 64.** Francis X. Gilhool, owner and applicant. Application HDC20-035 to replace wood frame windows with clad windows.
- V. Bulkeley indicated that although she is an abutter, she can review the application objectively.
- F. Gilhool presented. He thanked the members for scheduling a special meeting and stated that he is proposing Marvin Integrity, clad, replacement windows; they will be three over three like the existing windows, they are exactly the same size and will mimic what is there; all windows and the slider will be replaced; the visual look of the house will be consistent with what is there; they will be Marvin Hunter Green, which will match the house trim.
- V. Bulkeley noted that their house has Marvin hunter green windows and these will look the same.
- M. Myers noted that this is an exact replacement and there won't be any difference in the appearance of the house.

After asking for public comment and any additional input, on a motion by V. Bulkeley seconded by D. Neely, it was voted unanimously to close the public hearing and go into regular session.
